# **MINUTES:**

Rep Gary Gorniak was present to discuss purchasing of fish - Walleye fingerlings for Brevort Lake. The twp has purchased walleye in the past. The fall fingerlings are between 6-8 inches. The club is planning a purchase for this fall.

#### ST. IGNACE GOLF & COUNTRY CLUB:

General Manager Kurt Ney reports 39 Moran Twp members have received discounted rates, 22 free rounds to date for the 14 and under age group along with several discounted green fees for non-member township residents used by the monies from last years recreation fund.
