### SIGNS FOR SILVER MOUNTAIN BIKE TRAIL:

Supr Dionne met with Quincy Ranville, St. Ignace Visitors Bureau Events Director to discuss signage for the Silver Mountain Bike Trail. The Soo Tribe has offered to help with the cost. Will finalize sign wording and have signs installed in the spring. Also rules pertaining to usage of bike trail.

### ST. IGNACE FIRE CHIEF:

St. Ignace Fire Chief Nick Montie and St. Ignace City Manager Darcy Long were present to discuss the purchasing of a new fire truck. The cost of new truck is \$684,579.37 with a life expectancy of 30 – 35 years. The entities involved are City of St. Ignace – 43.81% (\$175,055.72), Moran Twp 37.86% (\$151,280.75) and St. Ignace Twp 18.33% (\$73,242.90). A down payment of \$225,000. The City will request of Moran Twp and St. Ignace Twp to allocate \$25,000 each from their 2<sup>nd</sup> half of ARPA funds toward the down payment. The City will allocate \$60,000. The City and Twps will ask the County for \$250,000 to help with the cost of the fire truck as well. Monies due upon delivery. MOTION BY SPENCER, SECONDED BY VALLIER (CARRIED) TO ALLOCATE \$25,000 FROM 2<sup>ND</sup> HALF ARPA AS LONG AS THE CITY OF ST. IGNACE ALLOCATES \$60,000 AND ST. IGNACE TWP \$25,000. TO BE ALLOCATED WITH THE DOWN PAYMENT.
