RECREATION:

Acting St. Ignace Recreation Director Scott Marshall was present requesting approval for fitness equipment for The St. Ignace Little Bear East Fitness Center of which Moran Twp residents are given a reduced rate to use the facilities. Marshall states the exorcise equipment is in poor shape, needing replacement.

The plan is to replace a couple of machines every year. Marshall is requesting the twp purchase a "Seated Leg curl/extension Bench" and a "Ion Adjustable Bench" at a approx. cost \$4800.
