### **ASSESSOR UPDATE:**

Moran Twp Assessor Ed VanderVries attended a meeting on Sept 18, 2018 on HB6049/SB1025, 2018 Assessing Reform Update. The committee discussed changes that were being proposed.

MOTION BY DIONNE, SECONDED BY MALCOLM (CARRIED) TO AUTHORIZE ASSESSOR VANDERVRIES TO PROCEED WITH THE PURCHASING OF A NEW COMPUTER SERVER CONNECTING ALL TOWNSHIP OFFICES AND POSITIONS. COST ESTIMATED TO BE \$4000.00.

### **POVERTY EXEMPTION/ASSET TEST:**

Discussion of a checklist to determine the income eligibility for waiving property taxes. The Federal Poverty Exemption Income Guidelines have been adopted. A dollar amount and guidelines need to be adopted for an Asset Test. Treas Dionne to prepare a resolution and bring back to November board meeting.

### PHONE SERVICE PROPOSAL:

After examination of AT&T's proposal, the Board decided to stay with Charter for phone service. No savings in the service. Recreation Director, Kyle Brow will be asked to check on another phone service for the Tubing Hill, AT&T's cost is \$70 per month.

## BOULEVARD DRIVE/IRON BELLE TRAIL BICYCLE PATH PRELIMINARY ENGINEERING STUDY:

Before opening bids, the Board should approve extending the completion date of the study from November 1, 2018 to February 6, 2019.
