MINUTES:

PUBLIC COMMENT:

Ken Lind representative for EMS Insurance (Twp insurance) was present to update renewal policy. The renewal fee is \$4214.00, up \$46 from last year due to increase in property values. Ken recommends the Twp review and update its policies and procedures.

HENDRICKS TWP FIRE PROTECTION AGREEMENMT:

Bill Cheesman discussed with the board fire protection equipment purchased last year with Moran Twp's contribution and future purchases. Cheesman recommends the Twp purchase a defibulator for the city of Brevort.

BREVORT DUMP:

The grant the township received in 1987 to cap the dump requires that we eliminate any trees growing within the fenced area. There are getting to be quite a few small trees growing on the fringes of the capped area. Supr Durm suggest the twp hire someone to remove these trees and mow the entire dump area. Durm to contact Kyle Brow, the twp contracted mower, about doing this.

MORAN TOWNSHIP HALL:

Janis Holle was present to update progress on the Gros Cap Church. OLD BUSINESS:

MACKINAC COUNTY ROAD COMMISSION RESOLUTION:

Mackinac County adopted a resolution thanking Mackinac County Townships for the development and participation of the current annual county wide match program and contributing one-third of the cost for road construction and preservation projects. Increasing the match program due to the state road funding surplus General Fund revenue

of \$242,719.06. In the listing of twps., Moran Twp, was eliminated. Treas Dionne informed the Road Commission.
