ST. IGNACE LIBRARY UPDATE:

Director Skip Schmidt presented the Board with the St. Ignace Public Library 2017 Annual Report. The voted millage revenue from the City, Moran and St. Ignace Townships have had a significant positive impact on their budget. The library has been able to begin to employ the staff necessary to service expanded hours and programs, and has been able to positively address collection, technology and maintenance issues. Director Schmidt is retiring and his replacement is Alisha McGowen.
