STRAITS AREA SPORTSMAN'S CLUB REQUEST:

Organization President Gary Gorniak was present to request funding for Walleye planting in Brevort Lake to promote sport fishing and tourism in Moran Twp. The Club would like to plant up to 40,000 walleye fingerlings every 2 years. The cost to purchase 2" is .06 per fingerling and 6-8" cost would be \$2. The hope is to raise enough money by spring of 2018. An objection by resident Lee Ortman in using taxpayers money when not everybody hunts and fishes. Trustee Spencer stated that this would bring in many visitors to the area.

PARTIAL FUNDING WILL BE PROVIDED BY THE STATE AND WILL INCLUDE A COMBINATION OF FEDERAL HELP AMERICA VOTE ACT AND STATE APPROPRIATED FUNDS.
