REGULAR MEETING

The regular meeting of the Moran Township Board of Trustees was held on Wednesday, October 5, 2016 at the Moran Township Hall, W1362 US-2, St. Ignace, Michigan.

CALL TO ORDER:

Supr Durm called the meeting to order at 6:00 PM DST with the Pledge of Allegiance.

MINUTES AND TREASURER'S REPORT:

MOTION BY DIONNE, SECONDED BY MALCOLM (CARRIED) TO ACCEPT THE MINUTES AND TREASURER REPORT AS PRESENTED FOR THE SEPTEMBER 2, 2016 REGULAR MEETING, AND SPECIAL MEETING, SEPTEMBER 27, 2016.

PUBLIC COMMENT:

Resident Lee Ortman reports a near collision at the intersection of Old Portage Trail and Woods Road. A truck crossed over the center line on the curve, causing Ortman to take the shoulder. There are no paint lines visible on this corner. Would the Twp request the Mackinac Co Road Commission to paint the intersection center lines. Road Committee Goudreau states with EPA standards for the paint used on highways is not lasting for more than 2 years. The Mackinac Co Road Commission has submitted a federal grant for painting of center lines on primary roads in the county, but will not hear until spring on the grant. Chairman Goudreau states this is a problem in other areas of the township and county.

Library Manager Skip Schmidt present to thank the Board for the successful millage passed for the library at the August election. Also looking for a Moran Twp resident to be on the Library Board when an vacancy occurs.

Brevort resident Brian Rose lives on Shore Road. There have been problems with spreading chloride on this road and a recent fire, getting the fire trucks in on the narrow road. According to an article published in The St. Ignace News – it stated the Board will be going to the Mackinac Co Road Commission for advise, either to expand the road or abandon it. The September Moran Twp Board meeting suggested this issue be turned over to the MORAN TOWNSHIP ROAD COMMITTEE to discuss a solution, not the Mackinac County Road Commission. Mr. Rose will be advised of the meeting and asked to attend with his input.

JAIL MILLAGE REQUEST:

Mackinac County Sheriff Scott Strait was present to discuss the jail millage request proposal on the November 8, 2016 General Election and why the need for a new jail. The current jail was built in 1972 with a capacity of 28 inmates. Bond amount not to exceed \$12,350,000 – 20 year term.

Supr Durm is sending Lange Enterprises the twp marked up maps for revision. It was also suggested to get a laminated map for the Assessor.

OLD BUSINESS:

1. The Moran Twp Identity Theft Prevention Program has been reviewed with no Red Flag's being detected.

- 2. Trustee Spencer inquired if Supr Durm has contacted Scott Marshall, Recreation Director of Little Bear Arena into rates for Moran Twp residents being reduced. Supr Durm stated he had but Marshall has not returned his call.
- 3. Supr Durm contacted the State of Michigan Construction Code department concerning St. Ignace using Moran Twp Building Inspector for their inspections. The state stated this request has to come from the City of St. Ignace.
- 4. Calls from walkers concerning shoulder drop off's south side, on Gros Cap Road since repaving. Rd Chairman Goudreau states still waiting for leaves to fall off trees to get a better view. Guard rails still possible. Will definitely be looked at by the MT Road Committee on their fall tour.

- 1. Clerk Vallier states the Mackinac County Chapter of MTA will hold their fall dinner meeting on Monday, October 24 at the Newton Twp Hall, Gould City at 6pm at a cost of \$14. Those wishing to attend will let her know.
