## **MINUTES:**

Treas Dionne would like an addition to the Hendricks Township item in the February 3, 2016 paragraph concerning the increase of \$2500 for fire services. This is a ONE TIME increase to be revisted in 2017.

MOTION BY DIONNE, SECONDED BY MALCOLM (CARRIED) TO APPROVE THE MINUTES, WITH THE ADDITION, FOR THE FEBRUARY 3, 2016 REGULAR MEETING AND APPROVE THE MINUTES FOR THE SPECIAL MEETING HELD ON FEBRUARY 24, 2016. ALSO APPROVE THE TREASURER'S REPORT.

#### **PUBLIC COMMENT:**

Clerk Vallier reports the Public Hearing for the 2016-2017 Budget **can not** be held tonight. There was to have been a Public Hearing Notice published in the St. Ignace News. It was not published. The Board decided to hold the Public Hearing for the 2016-2017 Budget on Tuesday, March 22, 2016 at 10 AM DST.

### **ST. IGNACE LIBRARY:**

Skip Schmidt, Director of the St. Ignace Library addressed the board regarding a millage request. The library board is requesting a .50 mill from Moran Twp. The library has 2100 card holders of which 400 residents are Moran Twp citizens. The library budget for 2015 was \$123,000. Their monies come from 46% city of St. Ignace, 27% from Penal Fines, 2% from State Aid the remaining from grants and donations. In the last few years the Library has increasingly assumed a larger role in providing our communities with a variety of services and programs.

At the same time, their primary source of funding, the millage revenue realized from the City of St. Ignace is decreasing, as are other funding sources. County Penal Fines are not consistently reliable and have decreased. State Aid money has also decreased. After carefully examining the Library's financial situation, the Library Board of Trustees has concluded that the Library will be unable to continue to provide services and programming at the current level, and meeting the challenges of the future, unless there is an increase in revenue. Schmidt also presented the Board the 2015 Annual Report. Trustee Spencer asked why a .50 mill? Schmidt responded any monies would be appreciated. Trustee Spencer stated that a .25 mill would be more likely to pass. Treas Dionne asked who would handle Moran Twp monies? The City of St. Ignace takes care of the monies for the Library. (Schmidt to find out if Moran Twp can handle their millage monies, if passed.) *CORRECTION - Schmidt stated monies can be paid directly to the Library*. Schmidt to return to the April meeting to present wordage for the ballot proposal, which needs to be submitted by May 10 to be on the August Primary ballot.

### MORAN TOWNSHIP MACKINAC COUNTY RESOLUTION

To request an evaluation of Line 5 in the Straits of Mackinac

WHEREAS, Enbridge Energy is the owner/operator of Line 5 that transports crude oil and liquefied natural gas from superior, Wisconsin across Michigan's Upper Peninsula and through Moran Township, Mackinac County, Michigan where it crosses the Straits of Mackinac at the nexus of Lakes Michigan and Lakes Huron, continuing south through the Lower Peninsula to Sarnia, Ontario serving the energy needs of Michigan and Ontario, Canada; and

WHEREAS, Line 5 has been in service for over 60 years, and a serious leak in this Line could result in significant damage to the Great Lakes environment and economy; and

*WHEREAS*, the State of Michigan has legal authority to protect the bottomlands and waters of the Great Lakes;

*NOW, THEREFORE BE IT RESOLVED*, that the Moran Township Board of Trustees supports Governor Snyder's executive order to establish The Pipeline Safety Advisory Board, and it's current mission to seek proposals to evaluate Enbridge's financial viability to respond to an oil spill, and to assess alternatives to Enbridge's Line 5 pipeline.
