Supr Durm called the meeting to order at 6:00 PM DST with the Pledge of Allegiance.

MINUTES AND TREASURER'S REPORT:

MOTION BY DIONNE, SECONDED BY MALCOLM (CARRIED) THE MINUTES FOR THE JULY 7, 2015 MEETING AND TREASURER'S REPORT WERE APPROVED AS PRESENTED.

PUBLIC COMMENT:

Michael & Janet Paquin, W1252 Old Portage Trail were present to discuss the water overflow from their neighbors, Chris & Kathy Kittell W1256 Old Portage Trail. This has been a multiple year complaint. In the fall of 2008, Mackinac Co Road Engineer Dirk Heckman and Foreman Bill Wagner investigated the drainage. It was the recommendation to install a cross-culvert to carry the excess flow. This was done in October 2008 at a cost of \$5,400.00. It did not solve the problem according to the Paquin's. The Twp Board believes this is a property dispute between neighbors (who have never gotten along) and should not get any more involved. Discussion closed.

Per addition request at 09/02/15 Board meeting: Supr Durm asked if anyone would like to take action on this matter? No response.

BUILDING INSPECTOR:

Bldg Inspector Bob Bishop's Building License expires 09/16/2015. Supr Durm states Bishop is working on the renewal.

MOTION BY SPENCER, SECONDED BY MALCOLM (CARRIED) IF BISHOP'S LICENSE IS NOT RENEWED BEFORE THE SEPTEMBER BOARD MEETING, THE BOARD APPOINT RICHARD OLIVER AS THE INTERIM BUILDING INSPECTOR. IF BISHOP'S LICENSE EXPIRES THEN ADVERTISE FOR THE BUILDING INSPECTOR'S POSITION.

GROS CAP CEMETERY:

Sexton Jake Tamlyn was present to discuss his findings on the purchasing of a Columbariam for the Gros Cap Cemetery. After discussion to price and vendor the following was recommended:

OLD BUSINESS:

Treas Dionne inquired into the violation letter to Mr. Coffey for refusing to pay for a cremation burial in the Western Cemetery. Supr Durm stated he had not done this but will send a violation letter this week.

NEW BUSINESS:

Trustee Spencer states the MCRC raised Wildwood Lane in Brevort 12". Spencer received a complaint from a resident on Wildwood Lane that the MCRC after the 12" raise, never feathered in the drive-ways, leaving a foot drop. Road Committee Chairman D.J. Goudreau to talk with MCRC.

Treas Dionne received Metro Act monies in the amount of \$2,279.51.

Treas Dionne and Deputy Hill are attending a Treasurer's Conference in September.

Auto's to Go has dismantled his business to another location. Trustee Spencer states there are still 2 vehicles on the property to be removed. Grass also needs to be cut. Supr Durm to check with the previous owner, Pete Freier.

Supr Durm received a letter from Enbridge concerning an exercise along with EPA and Coast Guard. They would like to use the Town Hall for this teaching/exercise. Trustee Spencer states the Township Hall is not efficient enough for the parking of 20 or more attendees plus the exercise. The Twp Board agrees. NO to the request.
