Trustee Spencer suggests we ask someone from the Hendricks Twp Fire Department to attend the next meeting to explain and give details for additional monies. Supr Durm to contact.

#### **DUST CONTROL:**

MOTION BY MALCOLM, SECONDED BY DIONNE TO HIRE WILKINSON CORPORATION FOR THE PURPOSE OF DUST CONTROL WITH THE FIRST APPLICATION APPLIED ON TUESDAY, JUNE 23, 2015, SECOND APPLICATION WILL CALL WHEN NEEDED (DEPENDS ON RAINFALL).

Supr Durm to contact MCRC so they can grade the roads being treated. Also to find a rider for the Wilkinson truck to help find the roads.

#### STRAITS STATE PARK/FATHER MARQUETTE MEMORIAL:

The DNR and the Michigan Historical Center is moving ahead with plans to replace the Father Marquette Museum. Site planning and funding sources are being reviewed. One question that has come up is whether or not local governments are willing or able to come up with some local funding for this project. An amount of \$5,000 from each government unit was suggested. No action taken at this time, Supr Durm to check with other local governments and their response.

Treas Dionne suggested a public response letter be put in the News Letter on the Father Marquette Museum rebuilding. Supr Durm to write the article.

## **OLD BUSINESS:**

- 1. Boundary Road repair. In October 2014 a proposal was submitted to the City of St. Ignace by Payne & Dolan for repairs on local streets, one which was Boundary Road. Trustee Spencer states Boundary Road is not on the repair list for 2015. WHY? Supr Durm to check on this.
- **2.** Tom Wilk request to change bus stop for his children, was checked into by Zoning Admr Therrian and states this is a school matter. Wilk referred to the St. Ignace Schools.
- **3.** The City of St. Ignace Fire Contract was to have been received by the June 3, 2015 meeting. Have not received. Supr Durm to check on this matter.

**4.** The AMR report for the State Tax Commission was a subject talked about at the recent Michigan Twp Spring Seminar. Guidelines established to check on your local Assessor were given. Treas Dionne checked with Assessor Oliver and he is following their guidelines.

## **NEW BUSINESS:**

- 1. Doc Holle's Silver Mountain Manager Tamlyn to report outcome of a ski hill meeting. Items in need of repairs and ski hill work were established by the committee:
  - a. MOTION BY DIONNE, SECONDED BY SPENCER (CARRIED) TO ALLOW THE PURCHASE OF CLEATS AND A BELT FOR THE GROOMER IN THE AMOUNT OF \$1600.00 AND WORK ON THE EAST SIDE SKI HILL TO BETTER PREPARE FOR SKIING AND SNOWBOARDING IN THE AMOUNT OF \$2321.
  - b. MOTION BY SPENCER, SECONDED BY MALCOLM (CARRIED) TO CONSTRUCT CONCRETE PADS FOR THE DISC GOLF COURSE, 40 PADS IN THE AMOUNT OF \$5360.

Manager Tamlyn also submitted for review a cost estimate for a Columbarium, used for above ground placement of cremation ashes.

- 2. MOTION BY VALLIER, SECONDED BY SPENCER (CARRIED) TO HIRE TODD BLAIR FOR THE POWER WASHING OF THE TWP HALL AND THE GARAGE AT A COST OF \$250.00
- 3. Janis Holle present to report on the Gros Cap Church. Holle states that an exhibit has been placed at the Fort DeBaude Museum in St. Ignace about the Gros Cap Church. Holle has checked with the state on historic grants. None available. In 2018 the Gros Cap Church will be 100 years old, at that time monies are available for historic renovations. There needs to be a historic district formed including the Gros Cap Church and surrounding historic houses this may also include St. Helene Island Lighthouse. Some steps in the planning.
- 4. MOTION BY DIONNE, SECONDED BY VALLIER (CARRIED) TO SIGN ROAD AGREEMENT WITH THE MCRC FOR REPLACEMENT OF 9 EXISTING CROSS CULVERTS ON THE GROS CAP ROAD IN THE AMOUNT OF \$12,640 (This road scheduled for repaying in 2016)
- 5. Supr Durm reports the DEQ has checked the old landfill in Brevort and reports it has passesd inspection.
