GRAYMONT REXTON PROJECT:

Graymont representative Darryl Browning was present to update on the project in Rexton. Graymont's operations are primarily the extraction of limestone, and the manufacturing of lime products. They estimate starting date of April 2015. The surface mine, near Hendricks and North East of Rexton, will involve up to 800 acres active at any one time. Development within the active area is expected to occur at a rate of 10-20 acres each year. All mined areas will be reclaimed as the quarry progresses.
