Jake Tamlyn, Manager of Doc Holle's Silver Mountain was present for updates at the Ski Hill. Equipment has been ordered to comply with State of Michigan regulations and the groomer axle is being repaired at this time. Tamlyn is requesting electricity to be installed in the new pole building. Tamlyn has obtained an estimate of \$1800 from a local electrician.
