MOTION BY DIONNE, SECONDED BY SPENCER (CARRIED) TO ACCEPT THE MINUTES AS PRESENTED FOR THE JANUARY 4, 2012 REGULAR MEETING.

PORTAGE STREET WATER PROJECT:

A letter received from Marv Winberg, Project Coordinator with Wilcox Engineering Service states the problem with the uneven paving of Portage Street Water Project is not due to poor quality workmanship by Payne & Dolan. The contractors involved feel that, other than the bumps at both ends, they restored the traveled surface to the best of their ability by matching the edge of the westbound lane and the edge of the paved shoulder adjacent to the eastbound lane. A ride on that paved shoulder will indicate how irregular that surface is. That unevenness has been reflected in the ride quality of the eastbound lane. Wilcox recommends that the use of contingency funds be explored with USDA in correcting the problem. USDA would need to pre-approve the use of project funds prior to proceeding with this approach to correcting the problem. There currently remains a \$77,000 balance of uncommitted funds in the project contingency.

Wilcox has experienced a current budget over-run of \$5,600. This over-run is associated with resolution of the paving issue associated with the marginal ride quality.

MOTION BY SPENCER, SECONDED BY MALCOLM (CARRIED) TO APPROVE ADDITIONAL MONIES OF \$5,600 TO WILCOX ENGINEERING BUDGET. ENGINEERING AMENDMENT NO. 2

CONTRACTOR'S PAYMENT #6:

MOTION BY VALLIER, SECONDED BY DIONNE (CARRIED) TO PAY CONTRACTOR'S PAYMENT #6 TO GLAWE, INC FOR \$38,527.87.

ST. IGNACE EVENTS COMMITTEE REQUEST:

Plans are underway to move the Pond Hockey Tournament and the WISSA Sail Competition to Boulevard Drive on Enbridge property. Enbridge is requesting a Waiver of Liability or "Hold Harmless" from Moran Township. Supr Durm will be out of town on Thursday so Trustee Spencer will check into options.

HOWARD EVERSON REQUEST:

Mr. Everson states he directly accesses city water from a city water line not Moran Twp's, therefore he should not have to pay Moran Twp Water Usage Fees. Twp attorney Evashevski's opinion states he does not believe the township can assess and collect fees to these customers or incurring any expense that is related to the city providing the service. It is city water delivered through city pipes. The township ordinance only imposes fees to users of the township system.

MOTION BY DIONNE, SECONDED BY SPENCER (CARRIED) ANY RESIDENT IN MORAN TOWNSHIP WHO IS NOT CONNECTED TO MORAN TOWNSHIP WATER LINES WILL NOT BE CHARGED MORAN TOWNSHIP USAGE FEES AS OF FEBRUARY 1, 2012.

Assessor Oliver states he has bought a new quad-core computer in the allotted amount approved (\$1500).

Assessor Oliver has been asked by CSZ, the reassessment company, to sign the roll. Oliver is reluctant to sign as he did not do the assessments. Jim Fenlon, Equalization Director recommends a certified letter be sent to the State Tax Commission, who ordered the reassessment, requesting in writing who is to sign the tax roll?
