<u>4TH STREET LIGHT UPDATE:</u>

Supr Durm met with Craig Davidson, ESELCO. They determined that a minimum run of 200 feet of power cable to power a street light at the intersection of Spring and 4th Streets. A costly job. The existing transformer is in the City of St. Ignace. The new street light will benefit township and city residents. This intersection is the east exit of the St. Ignace Elementary/Middle School. Supr Durm to talk with the City of St. Ignace is cost sharing the project.

RECREATION MILLAGE WORDING:

MOTION BY DIONNE, SECONDED BY SPENCER (CARRIED) TO SUBMIT THE FOLLOWING WORDING FOR THE RECREATION MILLAGE RENEWAL:

MORAN TOWNSHIP RECREATION MILLAGE RENEWAL

Shall the Township of Moran, County of Mackinac, Michigan, levy a tax of not to exceed one-fourth (\$.25) of one dollar (\$1.00) per one thousand (\$1,000) on the State Equalized Value of all taxable property in the Township and shall limitation on the amount of taxes which the Township may levy be increased by the same amount for a period of four (4) years, the years 2010, 2011, 2012 and 2013, inclusive, for the purpose of providing funds for the support and development of recreation in Moran Township?

Revenue to be generated the first year by this proposal is approximately \$21,986.00.

IGNACE CITY MANAGER CONCERNING THE NEW WATER PURCHASE/MANITENANCE AGREEMENT NEEDED FOR THE UPCOMING WATER PROJECT. THE NEW AGREEMENT MUST BE IN EFFECT FOR 40 YEARS, ACCORDING TO DUANE REID, SPECIALIST WITH THE USRDA.
