Supr Durm called the meeting to order at 6:00 PM DST with the Pledge of Allegiance.

PUBLIC COMMENT: Chuck Malcolm voiced an opinion on recent increase of Trustee salaries.

MINUTES:

MOTION BY SPENCER, SECONDED BY DIONNE (CARRIED) TO APPROVE MINUTES AS SUBMITTED FOR THE MEETING OF MAY 7, 2008.

CANDIDATES:

Candidates Nora Massey, Leroy Pieri and Frank Harness running for Mackinac County Treasurer in the August Primary, introduced themselves.

MACKINAC COUNTY MOWING CONTRACT:

Mackinac County Road Commission (MCRC) has decided not to mow grass along county roads this summer, due to lack of funds. Trustee and M.T. Road committee member, Mark Spencer requested from the MCRC an amount to do township mowings. The MCRC submitted a Road Agreement for Mowing Maintenance in the amount of \$6,000 (one mowing). Trustee Susan Dionne suggested paying under protest. Supr Durm states there are adequate funds in the M.T. road fund, if funds become available to the MCRC, we request to be reimbursed. Trustee Spencer states there are approx 41.7 miles of county roads in Moran Township. The State of Michigan has also stated it will not do mowings for grass along state roads either, due to lack of funds.

MOTION BY SPENCER, SECONDED BY DIONNE (CARRIED) TO ACCEPT THE MACKINAC COUNTY ROAD COMMISSION AGREEMENT FOR MOWING MAINTENANCE TO TOWNSHIP ROADS IN THE AMOUNT OF \$6,000. MONIES TO COME FROM ROAD FUND.

ROAD AGREEMENT FOR OLD PORTAGE TRAIL:

Residents Chris and Kathy Kittell have been experiencing significant flooding in their front yard, located at W1256 Old Portage Trail, for several years. They are requesting a culvert to eliminate the problem. Supr Durm, Road Committee member Spencer along with the MCRC Foreman Bill Wagner met to discuss the problem. All agreed a culvert needs to be placed. Trustee Spencer states Griffin Beverage is planning to build a warehouse across from Kittell's. Spencer to check with plans to make sure Griffins drainage will not affect Kittell's, before installation.

MOTION BY VALLIER, SECONDED BY HEUER (CARRIED) TO ACCEPT MACKINAC COUNTY ROAD COMMISSION ROAD AGREEMENT FOR INSTALLATION OF CROSS CULVERT AT W1256 OLD PORTAGE TRAIL IN THE AMOUNT OF \$5,900, TOWNSHIP COST \$5,400.

FAMILY BURIAL'S AT MORAN TOWNSHIP CEMETERIES:

Clerk Vallier states there have been several requests for burials on family plots. Cemetery Sexton Jake Tamlyn, also Sexton for St. Ignace Cemeteries and Catholic Cemetery, states their cost is \$100. Moran Township has been charging \$50. MOTION BY DIONNE, SECONDED BY HEUER (CARRIED) TO RAISE BURIAL ON FAMILY PLOTS TO \$100.

APPOINTMENT TO MORAN TOWNSHIP PLANNING COMMISSION BOARD:

Member MTPLC Suzy Hartley, is resigning. Ron Cotton is interested in serving.

MOTION BY VALLIER, SECONDED BY DIONNE (CARRIED) TO ACCEPT SUZY HARTLEY'S RESIGNATION ON THE MTPLC AND APPOINT RONALD COTTON, TERM ENDING 2011.

REAPPOINTMENT TO MTPLC & MTZBA:

MOTION BY SPENCER, SECONDED BY VALLIER (CARRIED) TO REAPPOINT NICKI KRYKOWSKI THE MTPLC AND JOEL SHEFFER TO THE MTZBA, TERM EXPIRING 2011.

GRASS MOWING BIDS:

It was discovered after awarding bids for the 2008 Grass Mowing season, that Kyle Moses was under 18. Supr Durm discussed with the insurance carrier who strongly urged the Township to not employ anyone under the age of 18 for mowing. After discussion with Tammy Moses, Kyles mother, Supr Durm recommends the Board approve Tammy Moses who agrees to the same terms of the contract, originally approved for Kyle.

MOTION BY SPENCER, SECONDED BY HEUER (CARRIED) TO AWARD THE ORIGINAL CONTRACT (\$125 PER MOWING) TO TAMMY MOSES FOR BID TWO, WESTERN CEMETERY AND COMMUNITY CENTER IN BREVORT.

HOSPITAL SPECIAL ELECTION:

MOTION BY SPENCER, SECONDED BY HEUER (CARRIED) TO BILL MACKINAC STRAITS HOSPITAL FOR EXPENSES INCURRED AT THE TUESDAY, MAY 6, 2008 SPECIAL ELECTION. TOTAL COSTS \$928.93.

NEW BUSINESS:

- 1. Sexton Jake Tamlyn notified Clerk Vallier that the vault building located at the Gros Cap Cemetery needs to be replaced. Supr Durm to advertise for bids to replace the roof.
- 2. Sexton Mark Spencer states the utility shed located at the Western Cemetery in Brevort needs to be replaced.

MOTION BY VALLIER, SECONDED BY HEUER (CARRIED) TO BUY A NEW UTILITY SHED FOR THE WESTERN CEMETERY.

3. Treas Dionne had a request from a citizen during Spring Clean-Up Day concerning a hazardous waste pick-up. Frank Harness stated Clark Township (Cedarville) had a hazardous waste day and the Watershed Council from Sault Ste. Marie helped them to set it up. Supr Durm to contact them. Matter tabled.

OLD BUSINESS:

1. Trustee Spencer informed the Board that the Fire Fighting Agreement with Hendricks Township has expired. Trustee Spencer would like to see it continued. Hendricks Township agrees to Fire Fighting Coverage in the Brevort area west of W3300 Gridline and south of the N5100 Gridline for a flat rate of \$5,000.

MOTION BY SPENCER, SECONDED BY DIONNE (CARRIED) IF HENDRICKS TOWNSHIP AGREES TO THE FIRE FIGHTING COVERAGE AGREEMENT IN BREVORT THAT MORAN TOWNSHIP PAY A FLAT RATE OF \$5,000 FOR ONE YEAR, EXPIRING JUNE 1, 2009.

Trustee Spencer would like Supr Durm to contact Trout Lake to discuss a similar agreement for the Fire Fighting Coverage in the Ozark for a flat rate of \$2,000.
