**3.** MACKINAC COUNTY ROAD COMMISSION (MCRC) INVOICE # 07-166 for Pte. LaBarbe road project in the amount of \$267,051.06. MT Road Committee recommended this invoice be paid.

#### **ENBRIDGE CONSENT JUDGEMENT:**

Consent judgement papers received from Twp Attorney Evashevski.

MOTION BY SPENCER, SECONDED BY DIONNE (CARRIED) TO AGREE TO THE TERMS OF REPAYMENT IN THE CONSENT JUDGEMENT FOR THE ENBRIDGE MICHIGAN TAX TRIBUNAL CASE AND AUTHORIZE TWP ATTORNEY TOM EVASHEVSKI TO SIGN THE STIPULATION.

## **EDISON SAULT ELECTRIC CO MICHIGAN TAX TRIBUNAL CASE:**

Papers on the Edison Sault Electric Co Michigan Tax Tribunal Case were presented. Treas Dionne questioned revision to taxable values for the 2005 year. MATTER TABLED.

## **TREASURER'S RECOMMENDATION:**

Treas Dionne recommends that the Twp purchase a CD from the UP State Credit Union in the amount of \$350,000 from the Road Fund Account. The Pte. LaBarbe Road Project came way under the projected estimate. The bonds purchased for the project can be paid off after May 1, 2008, without penalty. BUT \$10,000 was paid for the processing of the bonds. Interest on the bonds is 4.7%. the CD will yield 4% interest. It is Treas Dionne's recommendation that a CD be purchased, rather than the bonds paid off. BOARD APPROVED.

## **MEETINGS ATTENDED:**

Supr Durm and Trustee, Road Committee member Spencer, attended the Mackinac County Road Commission meeting for the 2008 road projects in Mackinac County. The main project for MT is the paving of East Martin Lake Road.

Supr Durm attended a meeting in Clark Township with Supr Linda Hudson and Mackinac County Sheriff Scott Strait, concerning the purchasing of a noise meter for Mackinac County.

#### **OLD BUSINESS:**

Fire Chief Alfie Dyer of Hendricks Twp contacted Clerk Vallier concerning the 2% monies of the Sault Ste. Marie Tribe of Chippewa Indians. Supr Durm requested a share of the 2% monies last fall. Supr Durm stated we were turned down. The request for the 2% share, by Moran Township, was to help Hendricks Twp purchase the Jaws of Life for extractions in emergencies. (Western end of Moran Township).

Chief Dyer would like Supr Durm to submit another request for the spring 2% monies. Supr Durm to contact Chief Dyer.

A request from "Scenic Michigan" to become a member of their statewide organization, was received. MATTER TURNED OVER TO THE MT PLANNING COMMISSION TO REVIEW.

Clerk Vallier informed the Board of the next meeting for the Michigan Township's Association, Mackinac County Chapter. The meeting will take place March 3, 2008 at 7PM at the Moran Township Hall. Guest Speakers include a representative from the American Transmission Company and Sgt. John Bruno with the Michigan State Police on speed limit control in your township.
