- 1. Applicant wants to construct a building/structure, change a structure, or demolish a structure in Moran Township.
- 2. Applicant contacts, Craig Therrian, Moran Township Zoning Administrator. He will then issue the applicant the zoning requirements for the job.
- 3. When a site plan is provided Craig Therrian will verify that it meets Moran Township Zoning Ordinance. The fee will be determined and written on the building permit application.

If it doesn't meet the required ordinance a written course of action will be provided for in which the applicant can follow.

- 4. If within 500 ft. of a body of water or stream and will move more than 1 acre of soil a soil and erosion permit is required by L.M.A.S.
- 5. If proposed site is a "split in the property, applicant must consult with Equalization Department, Moran Township Act 591 Administrator, (906) 643-7310, and obtain a written certification.
- 6. If in a : Wetlands area, sand dunes area, endangered flower area, and/or coastal barrier zone area, applicant must contact the Department Environmental Quality at 906-293-5131 and obtain a written certification.
- 7. If well septic are involved, applicant must contact L.M.A.S. Sanitarian at 906-643-1105 and obtain a written certification. Step 3 is required to be signed prior to receiving a permit from L.M.A.S for well and septic.
- 8. Olsen reviews structural drawings and verifies the above. If in order, he will collect fee stated in step 3 above and issue a Building permit. This permit is good for one year at the end of that year you may extend the permit for an additional year for a fee of \$25.00. At the end of the extension a new permit has to be applied for.

THE FOLLOWING INSPECTIONS ARE REQUIRED. FAILURE TO GET THESE INSPECTIONS WILL RESULT IN YOUR PEMIT BEING REVOKED/SUSPENDED.

- 9. The following are minimal required inspections after issuance of the Building Permit.
- a. Inspect foundation prior to pouring.
- b. Inspect framing
- c. Inspect final construction
- d. Electrical Inspection is required by the State of Michigan
- e. Plumbing inspection is required by the State of Michigan
- f. If proposed structure has central air conditioning, elevators, exhaust fans, or large refrigeration equipment, for inspection by State of Michigan, Bureau of Construction Codes
- 10. If **all** requirements are met an Occupancy Permit then will be issued.
