Representative Emma Cook, Senior Community Engagement Analysist was present to update the activities of Enbridge, concerning Line 5. A GEO Tech survey is being done, core samples are being taken of the lake bed and shoreline at a cost of \$40 million dollars. Supr Durm questioned the content of the core samples, Cook stated the samples are kept in a building in Cheboygan and if the board would like, she could set up a tour with the geologist.

One bid received: RE Carroll Construction, LLC in the amount of \$19,965 MOTION BY DIONNE, SECONDED BY SPENCER (CARRIED) TO ACCEPT THE BID FROM RE CARROLL CONSTRUCTION LLC TO REPLACE THE WALKWAY AT THE MORAN TWP HALL, INSTALL NEW KINGSTON RAIL ON BOTH SIDES OF NEW RAMP AND INSTALL A NEW DOOR FRAME WITH WINDOW AT ENTRANCE IN THE AMOUNT OF \$19,965.

DONALD LAWSON PROPERTY:

A summons had been issued to Donald Lawson to clean up his property on S 1154 Boundary Road. A certified letter received from Mr. Lawson detailing the reasons he cannot comply with Moran Twp order to clean up the blight on his property. The blight issue with Mr. Lawson has been long standing, with no success. The board advised Supr Durm to contact the Twp Attorney and proceed with the process.

OLD BUSINESS:

At the June 5 Board of Trustees meeting Trustee Spencer questioned the income and expenses for the Tubing Hill this past winter. Treas Dionne states the income from January 26 thru March 17, 2019 was \$4532.43 and the expenses were \$22,078.72 (payroll and supplies). Trustee Spencer suggests we some how decrease the expenses for next year.
