Due to higher costs, the Road Fund Professional and Contractual Services (201-446-801) Is over budget by \$169,012.46.

MOTION BY DIONNE, SECONDED BY KIMBERLING (CARRIED) THE PROFESSIONAL AND CONTRACTUAL SERVICES (201-446-801) ROAD FUND BE INCREASED BY \$170,000.00.
